- **THE PERMIT HOLDER IS NOT AUTHORIZED TO DISCHARGE A FIREARM FROM, ALONG OR ACROSS A PROVINCIAL ROAD, PROVINCIAL TRUNK HIGHWAY OR THEIR RIGHT OF WAYS, AND MAY NOT DISCHARGE A CENTER FIRE RIFLE, MUZZLELOADER OR A SHOTGUN WITH A SLUG FROM, ALONG OR ACROSS A MUNICIPAL ROAD, A LOCAL GOVERNMENT DISTRICT ROAD OR THEIR ROAD ALLOWANCES.**
  
- **NIGHT HUNTING PERMITS ARE NOT VALID:**
  - **BEFORE OCTOBER 11, 2022 IN APPROVED CROWN LANDS WITHIN PROVINCIAL PARKS**
  - **FROM NOVEMBER 14, 2022 to DECEMBER 4, 2022 INCLUSIVE, IN ANY APPROVED CROWN LANDS**
  
- **IF YOU REQUIRE FURTHER CLARIFICATION ON THE APPROVED AREAS YOU ARE WISHING TO HUNT, CONTACT THE LOCAL CONSERVATION OFFICER IN THE AREA PRIOR TO HUNTING.**
