**The fees payable by applicants and registrants are as follows:**

- a) For registration, or renewal of registration, or reinstatement of registration, as a mortgage dealer:  
 ..... **\$350.00**
- b) For each authorized official to be named in the certificate of registration of a corporation:  
 ..... **\$ 75.00**
- c) For registration, or renewal of registration, as a salesperson:  
 ..... **\$ 75.00**
- d) For the transfer of a salesperson's registration to a new employing mortgage dealer:  
 ..... **\$ 30.00**
- e) For any amendment which requires a correction of the certificate of registration:  
 ..... **\$ 30.00**
- f) For reinstatement of a salesperson, suspended under subsection 8(5) of the Act:  
 ..... **\$ 10.00**
- g) For any other reinstatement of a salesperson's registration:  
 ..... **\$ 30.00**
- h) For each examination pursuant to section 14 of the Act:  
 ..... **\$ 75.00**
- i) For a re-reading by the registrar of any examination included in a course prescribed under section 14 of the Act:  
 ..... **\$ 45.00**
- j) For any exemption pursuant to section 55 of the Act:  
 ..... **\$150.00**
